THE FOLLOWING AMENDED ORDER REFERS ONLY TO CHANGES IN ASSIGNMENTS. ALL PRIOR ORDERS NOT INCONSISTENT WITH THIS ORDER REMAIN IN FULL FORCE AND EFFECT.

IT IS HEREBY ORDERED THAT FOR THE PERIOD FROM JULY 1, 2009 UNTIL FURTHER NOTICE, THE FOLLOWING ASSIGNMENTS SHALL BE FILLED BY THE JUDGES OF THE ABOVE-ENTITLED COURT SUBJECT TO SUCH CHANGES AS MAY BE MADE BY THE PRESIDING JUDGE:

I. CRIMINAL PRESIDING JUDGE

Effective July 6, 2009 **HON. SUSAN IRENE ETEZADI** shall act as **Criminal Presiding Judge** with primary responsibility for the Master Criminal Calendar and the Superior Court Review Program.

II. LAW AND MOTION JUDGE

Effective July 1, 2009 **HON. JOHN L. GRANDSAERT** shall act as **Law and Motion Judge** through December 31, 2009.

III. FAMILY LAW DEPARTMENT

Effective July 6, 2009, **HON. DON FRANCHI** is assigned to act as a **Family Law Judge** and will handle **Family Law and Domestic Violence** cases.

IV. APPELLATE DEPARTMENT

Effective July 1, 2009, **HON. MARK R. FORCUM, Presiding, HON. H. JAMES ELLIS, and HON. CRAIG L. PARSONS** are assigned to the Appellate Department. **HON. ROBERT D. FOILES** is designated as the Alternate Judge in the Appellate Department. Such designations shall expire June 30, 2010.

V. GRAND JURY
