**I. CRIMINAL PRESIDING JUDGE**

Effective July 1, 2014, **HON. JONATHAN E. KARESH** shall act as **Criminal Presiding Judge** with primary responsibility for the Master Criminal Calendar and the Superior Court Review Program.

**II. LAW AND MOTION JUDGE**

Effective July 1, 2014, **HON. ELIZABETH K. LEE** shall act as **Law and Motion Judge**.

**III. JUVENILE JUDGE**

Effective July 1, 2014, **HON. CLIFFORD V. CRETAN** shall act as **Juvenile Court Judge**.

**IV. TRIAL COURT JUDGES – REDWOOD CITY**

Effective January 28, 2014, **HON. ELIZABETH M. HILL** is assigned to act as **Trial Judge** and other duties as assigned. Effective July 1, 2014, **HON. LISA A. NOVAK** is assigned to act as **Trial Judge** and other duties as assigned.

**V. APPELLATE DEPARTMENT**

Subject to the approval of the Chief Justice, effective July 1, 2014, **HON. LISA A. NOVAK, Presiding, HON. JOSEPH E. BERGERON** and **HON. JOHN L. GRANDSAERT** are assigned to the **Appellate Department**. **HON. LELAND DAVIS III** is designated as the **Alternate Judge** in the Appellate Department. Such designations shall expire June 30, 2015.

**VI. GRAND JURY JUDGE**

Effective July 1, 2014, **HON. SUSAN I. ETEZADI** shall act as **Grand Jury Judge**. This designation shall expire June 30, 2015.

**VII. COMMISSIONERS**

Effective April 28, 2014, **HON. STEPHANIE GARRATT** shall act as a **Criminal, Traffic, Small Claims and Family Support Court Commissioner** in Redwood City and shall perform all other duties as assigned by the Presiding Judge and Assistant Presiding Judge.
