

FELONY AND MISDEMEANOR BAIL SCHEDULE EFFECTIVE AUGUST 3, 2026

GENERAL INSTRUCTIONS

- A. This schedule is utilized by the Superior Court of the County of San Mateo pursuant to Article I, Section 12 of the California Constitution, Section 1269b of the Penal Code, and California Rules of Court, Rule 4.102, to set bail for the release of person arrested on felony charges without warrant for the alleged commission of any bailable offense. If a person is arrested pursuant to an arrest warrant, bail is set at the amount of the warrant.

This schedule as it applies to misdemeanors are for those exceptions to the mandatory release (signed “promise to appear”) provisions of Penal Code section 853.6. For those misdemeanor offenses not otherwise specified in the bail schedule (example: H&S section 11364, PC section 647(f)) bail is set at \$500.

- B. ***Variation on Set Bail.*** After a defendant’s first appearance in court, custodial status, setting of the amount of bail, and release alternatives will lie within the sound discretion of the judicial officer under the guidance of the California Constitution, Penal Code, and case law authority as outlined in the recent California Supreme Court decision *In re Kowalczyk* (2026) 19 Cal.5th 109. Pursuant to Penal Code section 1270.1 and 1275(c), the court may not set higher or lower than the bail schedule in cases of serious or violent felonies or designated sex cases unless a hearing is held in open court on two days written notice and within two court days of arrest.
- C. ***Judicial Review Required Before Release.*** Upon an arrest for a violation of Penal Code section 666.1 or Health and Safety Code section 11395, the arrestee shall not be released prior to judicial review, at which the court shall make an individualized determination of risk to public safety and likelihood of returning to court.
- D. The Bail Schedule shall contain a general clause for those offenses not specifically listed in the bail schedule. For all felony offenses and enhancements not listed, the bail amount shall be set according to the prison top term potential for the offense plus enhancement.

- E. Where this Schedule provides "Bail to be set by judicial officer", bail shall be set only by the Court upon proper notice and a hearing conducted pursuant to Penal Code § 1270.1 and Calif. Const., Art I, § 12.

- F. All references to a code section shall include all subsections thereof unless a specific bail is set forth for a particular subsection.

- G. The Bail Schedule contemplates the following practice where more than one offense is charged: When a defendant is booked on two or more charges arising from the same course of conduct on the same occasion, bail shall be the amount set for the charge having the highest bail. When a defendant is booked on two more charges arising from separate courses of conduct, bail shall be the sum of the amount set for the charge in each course of conduct having the highest bail. For sex offenses arising from threat or violence, bail shall be the sum of the full amounts set for each charge irrespective of whether the charges arise from a single course of conduct or single transaction.

EXAMPLE #1

This example demonstrates how to calculate the bail amount when a defendant is booked on more than one charge arising out of a single act that precludes multiple punishments.

Charge 1	PC § 460(a)	50,000
Charge 2	PC § 496(a)	10,000
Charge 3	PC § 487	10,000

The bail in this example is \$50,000 because the PC 459 charge has the highest bail and all the charges arise from a single act that precludes multiple punishments.

EXAMPLE #2

This example demonstrates how to calculate the bail amount when a defendant is booked on more than one charge arising from different acts that permit multiple punishments.

Charge 1	VC § 10851(a)	10,000

The bail amount in this example is \$85,000 because vehicle theft, hit-and-run causing injury, and DUI are separate acts that can be punished separately.
