Current Post Card Processing Information

The post cards are currently printed on-demand with variable information.

The variable information is encoded in one of two files that we send to the vendor.

File 1: .NEX file contains All notices except the second Failure to Appear notice. An example of the raw data in the .NEX file follows, along with example output. The records within the .NEX file will not be grouped by post card type, but they will be grouped by juror.

Upon receipt of the .NEX file, the vendor has a system that parses the data and performs a virtual layout for us to review. Once we review the virtual layout, we either approve the batch or notify them of any errors we encounter.

<u>File2</u>: .TXT file contains the second Failure to Appear notice (these are issued when a juror fails to appear on two different occassions.) an example of the .TXT file is below and an example of its output is included.

Detailed analysis of the data inside these files will be discussed with the awarded vendor.


