#### **Current Summons File Processing**

The summons file contains both blue and black printing.

The summons file is 8.5" x 14" and is duplexed.

Currently, the vendor batch orders the blue-printed summons sheets.

We FTP a file to the vendor that contains:

Juror Name and Address
Juror Badge Number
Juror Group Number
Juror PIN for accessing online and phone services
Reporting Date and Time
Reporting Location

Some of this information is repeated throughout the FRONT of the summons file only.

There are two spaces for "add-on" messages that apply to all summons. One is just above the perforated blue line near the bottom of the front of the summons. The other is below the address at the lower left corner of the front of the summons. (both are shown in-use on the example file)

The blue color does NOT need to be Pantone 301, so long as it is similar and consistent throughout our documents. We do not require drop-out blue.

There are two sets of perforations on the summons file:

One is below the signature field towards the middle of the summons. The other contains a vertical and horizontal perforation and is indicated by the blue dashed lines above and beside the parking permit on the front of the summons.
