

IT IS HEREBY ORDERED FOR THE YEAR BEGINNING JANUARY 1, 2025 THAT THE FOLLOWING ASSIGNMENTS SHALL BE FILLED BY THE JUDGES AND COMMISSIONERS OF THE ABOVE-ENTITLED COURT, SUBJECT TO SUCH CHANGES AS MAY LATER BE MADE BY THE PRESIDING JUDGE:

I. COURT ADMINISTRATION

PRESIDING JUDGE

HON. JUDGE STEPHANIE G. GARRATT shall act as **Presiding Judge** and shall perform all the duties prescribed for the Presiding Judge by the California Rules of Court and the rules of this Court as amended.

ASSISTANT PRESIDING JUDGE

HON. JUDGE RACHEL E. HOLT shall act as **Assistant Presiding Judge** and shall perform administrative duties as assigned by the Presiding Judge including serving as Presiding Judge.

SUPERVISING JUDGES

HON. SUSAN L. GREENBERG shall act as **Supervising Judge of Civil, Probate, Case Management and ADR Programs** and shall perform administrative duties as assigned by the Presiding Judge and Assistant Presiding Judge.

HON. RACHEL E. HOLT shall act as **Supervising Judge of Commissioners and Judges Pro Tem** and shall perform administrative duties as assigned by the Presiding Judge.

HON. ELIZABETH M. HILL shall act as **Supervising Judge of Criminal** and shall perform administrative duties as assigned by the Presiding Judge and the Assistant Presiding Judge.

HON. SUSAN M. JAKUBOWSKI shall act as **Supervising Judge of the Collaborative Courts** and shall perform administrative duties as assigned by the Presiding Judge and Assistant Presiding Judge.

HON. SUSAN IRENE ETEZADI shall act as the **Supervising Judge of the Juvenile Court** and shall perform all administrative duties as assigned by the Presiding Judge and Assistant Presiding Judge.

HON. SEAN P. DABEL shall act as **Supervising Judge of Family Law** and shall perform all administrative duties as assigned by the Presiding Judge and Assistant Presiding Judge.

HON. NICOLE S. HEALY shall act as **Supervising Judge of the Central Branch Court** and shall perform all administrative duties as assigned by the Presiding Judge and Assistant Presiding Judge.

II. SPECIALTY ASSIGNMENTS

CRIMINAL PRESIDING JUDGE

Hon. Kevin E. Dunleavy shall act as **Criminal Presiding Judge** with primary responsibility for the Master Criminal Calendar and the Superior Court Review Program.

HON. LELAND DAVIS, III shall act as judge for **Civil Case Management Conferences and Orders to Show Cause, Civil Mandatory Settlement Conferences, Informal Discovery Conferences, Orders of Examination, Long Cause Probate Trials, and Jury Trials for Unlawful Detainers.**

PROBATE JUDGE

HON. SUSAN L. GREENBERG shall act as the **Probate Judge** and shall supervise proceedings under the Lanterman-Petris-Short Act and shall perform all other duties as assigned by the Presiding Judge and Assistant Presiding Judge. Probate will be moved to the **Redwood City Courthouse.**

JUVENILE JUDGES

HON. SUSAN IRENE ETEZADI and HON. SHARON CHO shall act as **Juvenile Court Judges** and perform all other duties as assigned by the Presiding Judge and Assistant Presiding Judge.

FAMILY LAW JUDGES

HON. ROSENDO PADILLA, JR., HON. CHINHAYI C. CADET, HON. SARAH P. BURDICK, and HON. JENNIFER M. FROST shall act as **Family Law Judges** and shall perform all other duties as assigned by the Presiding Judge and Assistant Presiding Judge.


VI. APPELLATE DEPARTMENT
